Level I STANDARD Course Information

- Mission:** To build the competence and confidence of those who struggle to learn by training educators and developing programs.

- Requirements:** A **copy** of your diploma or transcripts is sufficient. Original transcripts are not required by NILD.
- Credit:** Four semester hours of optional graduate credit is offered at all locations. Upon successful completion of the course a certificate awarding six CEUs will be given to all participants.
- Class size:** Maximum 22. Registration closes – without exception – three weeks prior to the start date or when fully enrolled, whichever occurs first.
